

ADOPTED AUGUST 15, 1957


ESTABLISHING A BULKHEAD LINE
IN THE WATERS OF MARTIN COUNTY
MARTIN COUNTY, FLORIDA

At a regular meeting of the Board of County Commissioners of Martin County, Florida, held at the Courthouse in Stuart, Florida, at 10:00 o'clock A.M., Tuesday August 15, 1957, upon motion made by Commissioner Arnold, seconded by Commissioner Ricou, and unanimously carried, the following Resolution was adopted:

Whereas, pursuant to the authority granted by Chapter 57-362, Laws of Florida, 1957 the Board of County Commissioners did advertise notice of public hearing in the matter of establishing a bulkhead line in the waters of Martin County, Florida as appears more fully from the affidavit of publication hereto attached and by reference incorporated herein; and

Whereas, such public hearing has been duly held on this 15th day of August, 1957, and there being no objection thereto;

BE IT ORDAINED, by the Board of Commissioners of Martin County, Florida, that the bulkhead line for all of the navigable waters of Martin County, excluding the Indian River east of that part of Hutchinson Island in Martin County, and waters contained in or adjacent to incorporated municipalities, is established on a line uniformly one foot (1') out from the Mean High Water Mark and as shown on the map as recorded in the Martin County Florida, public records and by reference incorporated herein.



BE IT FURTHER RESOLVED, that a copy of this Resolution be sent to the Trustees of the Internal Improvement Fund of the State of Florida requestin the said Trustees to approve the said Bulkhead line.
