<b>SOCIAL MEMBERSHIP</b>	
<b>RIGHTS AND PRIVILEGES</b>	Member, spouse and unmarried children under age 26 have social, dining and tennis privileges. Social members may play golf up to five times in a calendar year (applicable green and cart fees apply). Social Members may not bring guests for golf in season and may only bring guests for golf in the off season if taking the summer golf option. Practice facilities are available only on the day the round of golf is played. May play in 9 hole Mixed Events on a space available basis ( <i>will not go against allotted five rounds</i> ). Eligible to take the Summer Golf option if available (full golf privileges from May 1 – October 31) each year. <i>Dates subject to change.</i> Guests are welcome for dining and tennis (guest fee applies).
