I/we further authorize any person(s) or organizations to disclose to the Club information requested by the Club and further agree to indemnify, defend and hold harmless the Club from and against any and all loss, cost, claims, injury, damage, or liability resulting from or arising out of any such acts.

## Entity Member Addendum



1. Applicant certifies to The Club at Ibis (herein referred to as “Club”), that Applicant is authorized by the Entity to apply for and to acquire a Club Membership for the purpose of either;

  - a. Designate a Natural Person to be the “Designated Voter” to exercise the voting rights of the Member.
  - b. Designate one Household Member (a Natural Person who resides in the Household) to be the Membership Designee who may use the Club Facilities.
  - c. Designate one other Household Member to be the Membership Second who may use the Club Facilities (if required).
3. Applicant understands that both the Membership Designee and Membership Second must also sign the Membership Application and be bound by its terms and conditions.
4. Applicant understands that as a Member, it may only change the Designated Voter once per Membership Year as set forth in the By-Laws.
5. Applicant understands that as a Member, it may request to change The Membership Designee and/or Membership Second to any other Household Member on the initial application only once per Membership Year by written request made at least 30 but not more than 60 days prior to the beginning of the Membership Year, and that until such request is accepted, such change shall not be effective.
6. Applicant understands that up to 2 additional Household Member Adults may be designated as “Associated Members”; that each Associated Member must apply and be approved for Membership in the Club and make payment of all required fees, charges and dues; and that a request to change Associated Members may be made only once per Membership Year by written request made at least 30 but not more than 60 days prior to the beginning of the Membership Year, and that until such request is accepted, such change shall not be effective.
7. The Applicant acknowledges that the Club is relying upon Applicant’s certifications and representations above in order to consider issuance of a Membership to Applicant, which certifications and representations shall become a part of the Membership Agreement upon issuance of a Membership to Applicant.

- Warm-up suits.

#### Fitness Attire

- Work out sneakers.
- No open sandals or dress shoes.
- Swimwear not allowed.
- Spiked shoes not allowed.
- Golf/tennis shoes allowed to/from locker rooms only.

#### Swimwear and Pool Attire

- Non-sheer cover ups are required over dry swimwear while not in the pool or on the pool deck.
- Wet swimwear is not allowed inside Club facilities.
