## DESCRIPTION

Old Marsh continues to preserve the true traditions of golf, with no tee times and an acclaimed caddie program. The Pete Dye-designed 18-hole championship golf course, offers 7,000 yards of superb golf, TifEagle grass greens, and breathtaking views.

Pete Dye drew on his vast experience as a golf course designer, as well as his experience as an international amateur golfer, to create a course that is both challenging for the finest golfers and enjoyable for the players of all skill levels.

The maintenance philosophy at Old Marsh is designed to further enhance the playability of the course. The course superintendent and maintenance crew are meticulous, paying close attention to every detail to assure an appropriate balance between absolute control and the natural character of the course. There is proof their hard work is paying off. In its first year of eligibility, Old Marsh was ranked among “America’s 100 Greatest Golf Courses.”

In 2016, the golf course was renovated and naturally, the project was overseen by Pete Dye and the Dye family. The pristine wetlands and wildlife, throughout the course and community, remain untouched and preserved.

The course’s drainage system is uniquely compatible with the natural environment. All of the water on the course is drained into canals or a series of retention ponds, rather than into the adjacent wetlands. Take a look at the local wildlife and it is obvious this system is working. Members and visitors notice a plethora of flora and fauna, including the Florida Sandhill Crane. The long-legged bird’s trumpeting call can be heard across the marshes, while their nests are seen along the edges of the course.

# SCHEDULE OF DUES, FEES & CHARGES

## RESIDENT & NON-RESIDENT



### DESCRIPTION

Nestled in a strikingly beautiful wetlands preserve, Old Marsh Golf Club is a private gated community of just 180 single family homes on 465 acres of land, embracing a Pete Dye Championship Golf Course listed among America's Greatest. The centerpiece is an elegantly appointed traditional clubhouse, reserved for 275 equity members.

Old Marsh Golf Club is designed to function as a traditional golf club, with the Club and Golf Course open year round. As such, Club policies including limiting the number of golf tournaments held per year, no men's or ladies' days, and eliminating tee times are intended to remain in effect permanently. One of the benefits of Old Marsh membership is the Club's outstanding caddie program from November 1st through April 15th. The Club urges all Members and guests to support the caddie program, one of the most valued of golf's traditions. Residents also have the option of owning their own golf cart.

# MEMBERSHIP APPROVAL PROCESS



All membership candidates must go through a process to ensure compatibility with our existing members. The Membership Committee effectively utilizes a Board-promulgated checklist and screening process. Our thorough process has always served the best interests of our Club and Members, and will continue to do so as we move forward. Property owners are required to apply for Equity Membership at the Club upon the purchase of a home, or lot, in Old Marsh. Membership by invitation only.

**Sponsors, Membership Committee & Board of Governors Role** - Sponsors are required to arrange for prospective candidates to meet with at least two members of the Membership Committee **prior to formally introducing the candidate to the application process**. The meetings may consist of a series of events, including golf, dining, or other social events. It is the goal of the Membership Committee to give the Sponsor feedback within 1-2 weeks of the initial meetings with Committee Members. Sponsors receiving positive feedback on their candidate would be encouraged to continue with the application & sponsorship phase of the approval process.

**Application & Sponsorship** - When the candidate and sponsoring member have concluded their initial meeting with members of the Membership Committee, and received positive feedback, the Sponsor may then submit an application on behalf of their membership candidate. All candidates will be required to have two current Old Marsh Equity Members as sponsors. Sponsors are expected to know the candidate well enough to express their opinion of the candidate's suitability for membership at the Club without reservation. Sponsors will be asked to confirm their support through a written letter which endorses the candidate's application for membership and attests to their general good character.

**Application Processing & Reference Check** - Upon submittal and acceptance of the application and accompanied by any required membership fee deposit, the Membership Director and Membership Committee will begin research of the candidate through background and reference checks. After completing the interview process, the Membership Committee will convene to determine if a candidate will be recommended for further membership consideration. Successful candidates will be posted for membership review for 14 days. The posting will include the name of the candidate, spouse's name, brief bio, city and state of residences, club affiliations and sponsor names. A photo of the candidate will be included. The posting will be displayed in the Men's and Ladies Locker Rooms and throughout the Clubhouse, as well as emailed to the entire membership. Existing members will have 14 days to comment on a candidate. Any additional letters of support are welcome and will be encouraged. Conversely, any member wishing to object to the candidate's application will be required to submit a letter to the Membership Committee before the end of the 14-day period.

**Final Review** - After the 14-day posting period and upon satisfactory membership review, the Membership Committee determines whether to recommend the candidate to the Board of Governors for final approval. If recommended and approved by a majority of the Membership Committee, the candidate's application file will be submitted to the Board of Governors for final review. The entire Board of Governors will review the file and give their final recommendation. In the event a candidate is not approved for membership, the General Manager, Membership Director or Chairperson of the Membership Committee will contact the sponsor to notify him/her, and their deposit will be returned.

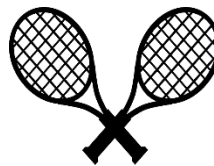
